| WHO NEEDS TO FILE: It is lawful for any person, business entity or political action committee (PA candidate, authorized candidate committee, PAC or political party committee be repaid for any purpose not prohibited by law to support or defeat a candidate. | e, to expend personally from that person's own funds a sum which is not to | | | |
| WHEN TO FILE: Any person, business entity or PAC making independent expenditures, elect expenditures, provided the total of the money so expended exceeds \$1000 w making the expenditure. | | | | |
| After a person, business entity or PAC files its initial report, the person, business entity or PAC shall file an additional report after each time the person, business entity or PAC makes or contracts to make independent expenditures, electioneering communications or covered transfers aggregating an additional \$1,000 with respect to the same election as that which the initial report relates. | | | | |
| When a report is required within thirty (30) days prior to the election to which hours of the expenditure. When such a report is required at any other time, it | ch the expenditure was directed, it shall be filed within twenty-four (24) t shall be filed within seven (7) days after the expenditure. | | | |
| WHAT TO FILE: Reports of independent expenditures, electioneering communications or covered transfers by a person shall contain the name, street address, city, state, zip code, occupation, employer, of the person responsible for the expenditure, the name street address, city, state, zip code of the person receiving the expenditure, the date and amount of each expenditure and the year-to-date total. The report shall also include a statement identifying the candidate or referendum that the independent expenditure or electioneering communication is intended to promote the success or defeat, and affirm under penalty of false statement that the expenditure is not coordinated with the candidate or referendum in question. | | | | |

| PENALTIES: Any person, who willfully and knowingly violates the provisions of Chapter shall be fined not more than \$1000 per violation.
